## **Fees**

Interactive Gaming Permit from a Canadian Licensing Authority to operate internationally (Exception U.S.)

- 1. 45k USD for the application fee/key person licence (This assumes 1 key person/it is 5k for each additional key person). (One Time Fee)
- 2. Consultation and Legal fees to work with Gaming License Beneficiary to (a) complete, (b) submit and (c) facilitate the application process and communications with the Gaming Authority is 45k USD (One Time Fee)

This includes the first year license to operate. Legal Gaming Authorization

License can be obtained within 3 to 4 weeks.

Yearly License Renewal 17k USD for the years following. (Unless changed by the commission)

Data Centre Server and other operational costs are extra.

3. Any additional work on Corporate structure or strategic advice can be billed out hourly (500/Hour) or we can scope out a flat fee on the basis of defining the scope of work.
